Brown's Creek

BCWD has identified several capital improvement projects along the Brown's Creek corridor to improve the water quality and habitat of Brown's Creek. The District will continue to partner with the DNR Trails to address stormwater and restore floodplain. The BCWD has received two FY 2013 Clean Water Fund grants to reduce temperature and sediment loading to Brown's Creek.

McKusick Lake/Diversion Drainage **Iron Enhanced Sand Filter**

The BCWD has received a FY 2012 Clean Water Fund grant to install an iron enhanced sand filter that will remove 118 pounds of phosphorous per year from the waters coming through the diversion structure to McKusick Lake and the St. Croix. The project will be constructed in 2013.



The Brown's Creek Watershed District (BCWD) is the governmental unit with primary responsibility for protecting the water resources of the Brown's Creek Watershed. The District was established in 1997 under the Minnesota Watershed District Act.

The District covers approximately 30 square miles within Washington County that drain into Brown's Creek, which then enters the St. Croix River. The watershed includes Brown's

Creek—a DNR designated trout stream, and several small tributaries. The watershed includes twelve major lakes and numerous wetlands. The District includes portions of the Cities of Oak Park Heights, Grant, Hugo, Lake Elmo, and Stillwater along with portions of May and Stillwater Townships.

The upper portion of the District is largely rural with farms, large-lot development and undeveloped grassland, cropland and forestland dominant. The lower portion of the District includes rapidly developing urban areas within the Cities of Stillwater and Oak Park Heights.


Brown's Creek

The namesake of Brown's Creek Watershed District and a designated metro trout stream hasn't been home to as many trout and cold-water insects as we would hope. Sediment and high temperatures are the problems. An implementation plan, approved by the MPCA in February 2011, identifies projects to improve Brown's Creek.

BCWD partnered with Oak Glen Golf Course to restore 1,300 linear feet of Brown's Creek as it flows through the golf course and added almost two acres of native buffer along the streambank. With the help of a Clean Water Legacy grant, this project began in 2011 and was completed in 2012 reducing the high summer temperatures so harmful to trout.

The development of the Brown's Creek State Trail provides an opportunity to partner with the DNR Trails on projects that would otherwise not be possible. The District addressed two locations of erosion on state land. Designs began to restore floodplain and address stormwater concerns.

Groundwater

Groundwater levels were measured in March & August 2012. Levels fell 1.8ft over summer and an average of 6.2 ft since 2002.






Brown's Creek entrenched along the rail
