

The Brown's Creek Watershed District (BCWD) has been responsible for protecting and improving the water resources in the 30 square miles of portions of the Cities of Oak Park Heights, Grant, Hugo, Lake Elmo, and Stillwater along with portions of May and Stillwater Townships for the past 20 years.

The newly approved 2017-2026 watershed management plan focuses implementation to improve Brown's Creek and the St. Croix River, as well as improving our lakes such as Long and South School Section.

Throughout 2016, the BCWD worked with Washington County to purchase a 13-acre parcel with 1,300 feet of Brown's Creek and 2.4 acres of wetlands. The property was purchase in January 2017. The BCWD will be working with stakeholders to develop a land conservation management plan in 2017.

With the help of the East Metro Water Resources Program partnership and the BCWD Citizen Advisory Committee, 2017 will be a great year for resident outreach. Our annual newsletter will be reinstated; there will be a monthly Open Yard series, several summer family pond exploration events, and a 20th Anniversary community event in the fall of 2017. We hope to see you join us outside for the fun!



2017-2026 Management Plan:

In 2016 we approved a plan of action to restore & protect our water resources.



South School Section Lake Curly-Leaf Pondweed Management:


In 2017 a survey and DNR permit will be completed, preparing for spring treatment.



Land Conservation in 2017:

The BCWD partnered with Washington County to acquire 13 acres of undeveloped land in Grant. This year we will be developing a plan to manage and improve the 1,300 feet of Brown's Creek, and 2.4 acres of wetlands and 5.2 acres of prarie and 5.4 acres of woodlands.





Lynch Lake Fish Management in 2017:

Working with MN DNR to annually stock walleye fry to manage the bullheads, allowing more rooted vegetation growth & reducing algae. Although most of the walleyes will be recaptured to stock in other area lakes, many will stay in Lynch providing some fishing opportunities in years following mild winters.

Brown's Creek 2016 Monitoring Loads to the St. Croix River:

Wettest year on record for Stillwater
TSS (sediment) = 241 lbs/acre (goal 74 lbs/acre)
TP (nutrients) = 3,514 lbs (goal 1804 lb/yr)



Long Lake Water Quality Improvements:

2016 Implementation: The Norell Ave Stormwater Pond Retrofit (collaboration with City of Oak Park Heights, 2015 CWF Grant) and Curbcut Raingardens (City of Stillwater, 2014 CWF Grant)



Cooling Brown's Creek:

2016 saw the installation of a rock crib in the Brown's Creek Park to reduce the peak summer creek temperatures. This project was a collaboration with City of Stillwater and a 2015 Clean Water Fund Grant.
